GPS tracking bill has many flaws

A month into the General Assembly session and after crossover, two identical bills were introduced to address the U.S. Supreme Court's ruling in *United States v. Jones*, which said that it is a "search" under the 4th Amendment if the police put a GPS device on someone's vehicle.

The bills, <u>HB 1298</u> and <u>SB 685</u> set out the procedures for "issuance of [a] search warrant for a tracking device."

Contained in these bills are two troublesome provisions. One would make it a *Class 1 misdemeanor* for the **unauthorized disclosure or publication of the existence of the search warrant**, its affidavit and more.

Public notices will remain PUBLIC

Though the attempts came from every conceivable direction, ultimately all of the bills that would have made publication of public notices in newspapers optional instead of mandatory have failed in their original form.

Many thanks to Delegates Mark Cole (R-Fredericksburg) and John Cosgrove (R-Chesapeake), and Sen. Steve Martin (R-Chesterfield) for amending their bills in favor of public access: Cosgrove's to add more information in ads for foreclosed timeshares in the paper, and Cole's and Martin's having to do with notices about a change in local voting districts or precincts.

Del. Ron Villanueva (R-Virginia Beach) lobbied intensely for his bill to move all state and local

requests for proposal (RFPs) out of the newspapers and onto the state website called eVa. In the Senate committee hearing, Villanueva rejected one senator's suggestion to require publication in *both* places. Sen. Richard Stuart (R-Westmoreland) was the bill's most vocal opponent in that same hearing, noting that the bill could cost the locality more because fewer people would be seeing the RFPs to bid on them.

The Virginia Press Association led the charge. VCOG provided additional testimony and lobbying efforts, and several other groups -- including the AARP, the League of Women Voters, and the League of Conservation Voters -- voiced opposition.

It was the right call, Virginia!

Open government news

A Senate Committee voted down a proposal to conceal concealed handgun permit applications. The measure, sponsored this year by Del. Mark Cole, but identical to bills brought in the past, would have shut off the only avenue for the public to monitor the permitting process. Access to the statewide database of CHP holders has been off limits for at least four years...The Jane Doe plaintiff in the lawsuit challenging the Christian prayer used at the start of Pittsylvania County Board of Supervisors meetings unveiled herself in early February as local activist and attorney Barbara Hudson....A federal judge dismissed a \$5 million libel suit filed by a former tax preparer against WAVY-TV in Norfolk over a report that referred to him as "unscrupulous." The judge found, among other things, that the statements were constitutionally protected opinion....A FOIA request filed by the Richmond Times-Dispatch to access records of 76 convicted felons who had not been notified that new DNA testing excluded them as the DNA's original source was denied by the state's Department of Forensic Science...The General Assembly was on its way to approving an overhaul to the way Virginians will access vital records. The measure, sponsored by Sen. Harry Blevins (R-Chesapeake) had the support the Library of Virginia, state genealogists and VCOG. The bill directs creation of a subscriber database of the records, as well as a publicly accessible index of the information within the records.
